- The TTV Board approve accepting the Table Tennis Australia MOU for 2023 with the TTV revised wording and the amended TTA contribution offer.
- The TTV Board approve the setting of a cash reserve target of \$350,000 and will aim to achieve this target by the end of 2026.

- The Table Tennis Victoria Board approve that the 2024 member fees are set at the rate of \$110 for adult competitive, \$90 for concession competitive and \$45 for social/coach and official.
- The Table Tennis Victoria Board approve that the 2024 affiliation fees are set at the rate of \$225 for affiliates with 5-50 members, \$275 for affiliates with 51-150 members and \$325 for affiliates with 151+ members.
- The TTV Board approve updating of the Policy and By-Law navigation to remove By-Law numbers
- and reorder.
- The TTV Board agree to the planned future development of the following policies: Board Charter, Delegations Policy, Health and Safety Policy/OHS, TOIL Policy& Parental Leave Policy.
- The TTV board approve and support the principle of a national membership structure change for 2025 subject to further due diligence, modelling and development.
