5 CORRESPONDENCE

5.1 Deniz Yener-Komeratsu – Deniz questioned why she wasn't awarded points for a walkover in the O/50 Womens Singles at the Melbourne Open while Christine Schindler was awarded points. General discussion. Rob proposed that a new by-law with two amendments be written up to ensure better clarity regarding rules of players not turning up for their scheduled matches.

5.2 Frank Hirst – Frank wrote to TTV again questioning if his letter dated 31 Aug 2016 was read by the Board and whether the issues raised were considered. The Board re-considered Frank's letter and discussed the matter. Board decided that Frank's concerns will be referred to the TTV Country Championships Committee and will also inform the Referee of the Vic Country Championships to monitor any "unsportsmanlike" behaviour.

7 AFFILIATION

The Board discussed the matter. TTV resolved to make registered players aware that the rule is there to encourage unaffiliated clubs to affiliate so as to protect the integrity of the sport.

Chrissy proposed that information handouts regarding this rule be given to players at next tournament.

8 COUNTRY WEEK MEETING – 10 DEC ATTENDED BY BRETT AND DENNIS

Brett and Dennis attending Meeting. Advised the TTV Country Championships Committee that the event must return a profit. Brett also informed the Committee that the entrants to the Championships will attract 6 Ratings Central points for participation.

9 NATIONAL PARA CHAMPIONSHIPS FEB 3-7 AND HALL OF FAME INDUCTEES

Mornington TTA will be hosting the National Para Championships. Besides Barak Mizrachi and Melissa Tapper, additional inductees were ratified by the Board – Rebecca Julian, Sarah Lazzaro, Nathan Pellisier, Catherine Morrow, Rory Carroll, Christopher Addis, Trevor Hirth and Cassy Geffke.

Action item – Dennis or Brett to present the HOF badges at the National Para presentation night or at TTV AGM.

10 RESIGNATION – JAMES POUNTNEY

TTV's State Development Officer James Pountney resigned from his TTA funded role on 16 Dec 2016. He made this decision purely from a financial reason as Badminton Victoria offered him a full time permanent position. TTA in conjunction with TTV tried hard to persuade James to stay with an offer to combine the funding for a full time role but to no avail.

TTV will work with TTA in relation to filling position as soon as possible.

11 TTA TRANSITION

Brett advised the Board that he will attend the TTA AGM in late April/May with the intention of being elected if the current TTA President steps down. This planned move will give TTV a stronger position in the future as there are currently no Victorians on TTA Board.

16 MSAC LICENCE

16.1 Simon Gerada – Simon emailed TTV requesting that TTV start looking at other stadiums to relocate to as MSAC has advised Simon that table tennis will no longer be accommodated at MSAC. The Board decided that TTV will seek to stay at MSAC and retain all current services provided by MSAC. Brett provided some general strategic options to the board. The Board has decided to give Brett the general authority to negotiate with MSAC on behalf of TTV – authority to last until next Board Meeting.

Action item – Dennis to advise Simon of TTV's intention and to consider Simon's option at a later date.
